We should be observing that day with the same reverence as we accord the other various Marine Corps Dates...Perhaps even more so! An old Gunnery Sgt. commanding his platoon in the absence of their wounded Lieutenant, who had fought in the Philippines, Vera Cruz, Santo Domingo and at the Walls of Peking, left the security of the woods first, and turned to his troops and said, "Come on, you sons-O-Bitches! Do you want to live forever? **THE DEVIL DOGS WERE BORN.** Our predecessors left us a heritage second-to-none.

We the lowly curs that have followed them, must never forget what they did, nor their sacrifices. Caring to call ourselves Devil Dogs, we must never lose sight of their deeds, or bring discredit to the name **DEVIL DOG...** It should be one, that only reflects good deeds and acts of honor. In accepting the title, Devil Dog we must never forget what it stands for. Just as much pride, as you reserve for the Eagle, Globe and Anchor, you should also be willing to commit to the title, Devil Dog and perhaps a little extra. By the way, that Gunnery Sgt. was Fourty Four year old 1st Sgt. Dan Daly. On the morning of June 6th, 31 officers and 1,056 Marines were casualties and history was being written. On June 30th the French renamed Belleau Wood to bear the name henceforth as, "Bois de la Brigade de Marine."

THE BARK, BITE & HOWL OF THE KENNEL!

THE CHIEF SEZ:

This is our last Woof-O-Gram of the year. It is only eight (8) weeks until our 50th Anniversary Supreme Growl in Dallas Texas. Every Devil Dog should make every effort to attend. Because this is our 50th Anniversary we will be registering all Devil Dogs, Pups, DD, and PDD's. Although this will not allow Pups and DD to attend the Supreme Growl, they will receive a Dog Tag, Patch and a Mug and be allowed to join in any planned events during the convention. You must have a 1988-1989 Devil Dog Membership Card and be a paid up member of the Marine Corps League to do this. You must have these cards with you - do not depend upon the Kennel Dog Robber to check this out in the Dog House - this is your responsibility - check your cards before you leave home.

With the help of the Kennel Staff, elected and appointed officers - plus the rank and file this has been a great year for me. I set up a Panel to study the Procedure for Initiation of Candidates. By 1990 we hope to have a set plan in place but for the present we studied and discussed the 1989 Initiation in Dallas, Texas. We still have to finalize procedures but I can tell you the following:

There will be no more hazing during the initiation. You will wear your street clothes and cover during the initiation. No one will be allowed to touch the Devil Dogs or the bone.

Initiation Team will consist of our Mad Dog, "Bubbles" and the initiation team comprising of twelve. This team will wear gold arm bands at all times and be the only ones to join in during the initiation on Thursday afternoon. If you want to be on the initiation team, submit in writing to me your request, and in Dallas, "Bubbles" and I will discuss and she will pick the men she would like to assist her.

Immediately after the initiation the Devil Dogs advancing from PUP to DD will be sworn in by the Chief and dismissed. All Devil Dogs advancing from degree of DD to PDD will be excused until a time set by the Chief - and at that time they will assemble outside the Growl room along with the Mad Dog "Bubbles" and shortly thereafter brought into the Growl and take their oath.

I know there will be some Devil Dogs that will resist the change of no hazing. However we cannot do what we did years ago in 1989. Our organization is a Proud one and we get the "Cream of the Crop" - however, I believe we could have many more Devil Dogs aboard that would be an asset that do now join when asked simply because they do not believe in hazing. They are not "afraid" Whimps", etc. they simply, along with law enforcement agencies feel hazing should be out.

Hopefully we will start our 51st year on this new version of initiation and will prosper and grow -- some Devil Dogs think I am "Smoking funny cigarettes" when I say I believe that by the end of 1990 we will be up at least 1,000 members.

DOG HOUSE IN DALLAS, TEXAS

PCDD Ken Farris is in charge of the Dog House. The hours are as follows:

Monday, August 7, 1989.....9:00 a.m. through 5:00 p.m.

Tuesday, August 8, 1989.....9:00 a.m. through 5:00 p.m.

Wednesday, August 9, 1989.....9:00 a.m. through 12:30 p.m.

Thursday, August 10, 1989.....9:00 a.m. through 12:00 noon

You must first register with the Marine Corps League before picking up your Devil Dog registration. Devil Dogs advancing a degree must be registered by Wednesday, August 9, 1989 at noon. Thursday registration is just for PDD's who are coming in for the Growl Thursday evening.

Kennel Mad Dog PDD Connie (Bubbles) Barrick would like all Devil Dogs advancing a degree to know the following:

1. You must be registered by the League and Kennel before you see her.
2. You must have your Application for Degree Advancement completed, Top section with Name and Address and then Section II must be completed. You will note it must be signed not only by you but your Pound/Pack Dog Robber. Your Pound Dog Robber has these forms or they can be obtained from PCDD Ken Farris.
3. Bones: You must pay \$20.00 deposit for a dog collar that you will wear - this is refunded when collar is returned. (Dog House will be open Friday morning just to refund these bones.)

You must buy a Passport for \$5.00. PDD Bill King will be handling stamping of Passports and selling them.

You will receive three books of chances to sell or buy - total cost will be \$15.00.

You will be required to buy a bone that is worn around your neck at a cost of \$2.00.

Please be prepared to pay in cash - if you have a check cash it at the front desk - reason for this is many Devil Dogs are hadling this procedure and we want to keep our funds straight.
