

Many letters, telephone calls and happenings at growls show that the PASSPORTS are still not clarified in many of the Devil Dogs minds. After the Mid-Winter Meeting/Growl in Virginia, I will be issuing a report and see if we can get a unified idea of just what the PASSPORTS

# Honoring the flag's daring defender

HAMILTON — Princeton University's flag burners had their media event last week.

Last night, Alexandra Di Campi, the Princeton University flag protector, took her turn in the spotlight.

Di Campi, 17, was the Princeton sophomore who snatched a flag from two protesters last Wednesday as they were about to set it ablaze with a butane lighter.

After grabbing the flag, Di Campi broke into a sprint and darted into Dodds Hall, a dormitory, where she dropped the flag into a mail slot of a friend. She later reclaimed it and hung it on her wall where it remains today.

That daring rescue effort was honored last night by the Trenton detachment of the Marine Corps League, a group filled with veterans who are known to have had a few dares in their time. Several members fought at Iwo Jima, and others recalled the wounds they suffered in battles.

**BUT THERE WERE** no generation-gap tensions last night. They saluted Di Campi as a hero, a patriot, one of their own.

"I thank you," said detachment Commandant Al Hujdich, in front of reporters and TV cameras at their modest Schiller Avenue Hall. "You did a heartfelt thing."

Hujdich then turned to her and gave her a hand salute. The place erupted in applause.

Di Campi, from Chester Heights, Pa., said she never considered herself a zealous defender of the flag. But when she saw protesters Oleg Urminsky and Dan Delaney, Princeton University students, parade around the quadrangle with a flag upside down and backwards, Di Campi, a member of Princeton's rugby team, got steamed.

"They were making a big spectacle of it," she said, after receiving a framed citation from the veterans. "I found their rhetoric to be very hollow."

But what really made her bristle was that the two protesters had called the media "from New York to Wilmington" to attend the event. They staged the event to protest a federal law passed Oct. 5 that outlaws desecration of the American flag.

"They made a big production out of it," she said. "It really made me mad."

**THE FLAG BURNING** did not accomplish anything, she said. If the protesters really wanted to effect change, then they should organize students to petition their political leaders. In effect, they could have done something constructive and positive, she said.

"By doing that (the flag burning), they are rejecting everything

that America stands for," said Di Campi, who attended the event in blue skirt and a maroon sweatshirt with the greek letters of Phi Delta Pi sorority. Her dress served as a stark contrast to the veterans' fire red blazers and narrow service caps trimmed in gold braid.

She was a big hit with the vets. She politely posed for pictures. One vet wanted to send a photo to his son, who is now serving in the Marines.

All Devil Dogs should be extremely proud to see such a fine individual wearing the picture of a Devil Dog and the name of our beloved Corps.

The Body was led in the Pledge of Allegiance to the Flag and salute to the colors by the Honorable Kennel Police Dog (Acting) Gerard R. Finn. The opening prayer was read by the Honorable Kennel Dog Trainer PDD Michael Macera. This Supreme Growl was dedicated to the memory of Past Chief Devil Dogs William Hurrell and Fred Agosta and Past Kennel Dog Robber Manuel Valdez.

The National Executive Secretary called the roll of the Board of Trustees. Two were absent.

MINUTES - 50th SUPREME GROWL

MOTION was made by PDD Ferne Lauter to approve the Minutes of the 1988 Supreme Growl and the Motion was approved.

A Memorial Service for the deceased Devil Dogs of the previous year was conducted by the Honorable Kennel Dog Trainer PDD Michael Macera.

The Chairman of the Audit Committee, PCDD Jay Kacsan reported that the Kennel books had been audited and found them to be in balance and in excellent condition. A MOTION was made by PDD Guy Wickcliffe to approve the audit report and the motion was approved.

The Honorable Kennel Dog Robber read the 1988-89 Financial Report to the assembly. Total assets of \$17,808.13 were reported. A MOTION was made by PDD Marvin Rombach to accept the Financial Report and was approved.

The National Executive Secretary, PCDD Kenneth E. Farris reported that the Kennel had reached a strength of 2045 members as of 30 June 1989. The three top Pounds of the Order are Pound 6 (Michigan) = 103 ; Pound 136 (New Jersey) = 58 ; Pound 153 (West Virginia) = 53.

The Honorable Senior Vice Chief Devil Dog, PKDR Hyman Rosen gave his report on the annual fund raiser. After expenses \$2025. was raised.

PCDD Edwin F. Gallagher, Chairman of the 50th Anniversary Committee gave his final report.

PCDD Gilbert E. Gray, Chairman of the Childrens Hospital Committee reported that the sum of \$2,000. was donated to the Childrens Hospital Foundation of Dallas, Texas.

PCDD Paul L. Sutton on behalf of the Past Chiefs Society presented plaques to those they felt should be especially honored for their contributions to the Military Order of Devil Dogs over the years. They were PDD Michael Kneefe, PDD Anthony Savino, PDD Daniel Pfeiffer, PKDR Leo Fortier, and PCDD Claude Downing.

MOTION was made by PCDD Paul L. Sutton to increase the Kennel Dues to \$5.00 effective with the 1990-91 dues because of increased costs of operation and a projected increase in the US Postage next year. The Motion was approved.

PDD Clem Russell made a special presentation of a painting to Chief Devil Dog Krauss and PCDD Thomas A. Banks.

PDD Clifton Williams presented a gold armodillo to Chief Devil Dog Krauss. The Ohio Pack was permitted to present Purple Bone Awards to PDD James Lahr, PCDD William Brooks, and PDD Linwood Liner.

MOTION was made by PDD Joseph Callahan to donate \$2,000. to the MCL Scholarship Fund and \$500. to the Physical Fitness Fund. Motion was carried.

PDD Marvin Rombach raffled off a Carbine and the receipts of \$200. were donated to the MCL Scholarship Fund.

The new Pedigreed Devil Dogs were obligated by Past Chief Devil Dog Paul L. Sutton.

The 50th Supreme Growl of the Military Order of Devil Dog was adjourned at 2345 hours to be reconvened in Sacramento, California in August 1990.

It seems there are lot of members, even old time ones, who do not understand the membership card and dues payment procedures in this organization. For their benefit I will recount what transpires.

The Fiscal Year of the Kennel runs from 1 July to 30 June, because it must agree with the Marine Corps League Fiscal Year, since we are part of the report to Congress, each year, by National Headquarters, Marine Corps League.

The membership year runs from from 1 September to 31 August, each year. Why is this? Because each member must have a paid up membership card should they attend the Supreme Growl in August. When your card expires on September 1, you are not at once in a delinquent state. You have until 31 December to pay your dues. If not paid on that date, then you are are delinquent.

For those of you that belong to the American Legion, they have a similar procedure. Why is this? Formerly all Marine Corps League memberships expired on 31 August. You had to have a current card from the League to obtain your Devil Dog Card, thus the 120 day grace period in the Kennel. Technically, you should still have a paid up League card to obtain your Devil Dog card, but because of the revolving expiration dates in the league, this is not practical or possible.

In theory you should not be fined, September through December, for not being in good standing, at a Growl. Cards are not issued in July and August because we do not have them. Cards are not printed on demand by the computer, they are run once a year, enmasse, in September. All changes from the Pack Growls in June, and the Supreme Growl in August, must be entered into the program before the cards can be run.

In addition to this, after 1 July the annual Financial Report must be prepared, the books balanced and readied for the Audit Committee. The annual membership count for the Kennel computed, supplies for the Supreme Growl, and records packed to go to the National Convention.

All this by one person.

#### WHAT IT IS

The military Order of Devil Dogs is the Fun and Honor Society of the Marine Corps League.

#### WHAT IT DOES

It promotes good fellowship amongst the members of the different Marine Corps League Detachments. #### WHO BELONGS

The Pup wears the black ribbon, the Devil Dog wears a red ribbon, and the Pedigree Devil Dog wears a gold ribbon. The ribbon is worn around the neck and a dog tag is attached to it.

The head of the Pound is called the "Poundkeeper". The head of the Pack is called the "Pack Leader." The head of the Kennel is also the head of all Devil Dogs and is called "Chief Devil Dog."

The Order's many charitable donation not only help people, but also build good public relations for the Order, the League, and the United States Marine Corps.
