Woof-Woof,



I would like to introduce myself as your new Kennel Executive Director, many of you know me already. I attended the Mid-Winter Conference and Mini-Growl and got to speak to many more Dogs, and I welcome these new friendships.

I was humbled and very apprehensive when Chief Devil Dog Tom Hazlett asked me to be the Executive Director. It took several phone conversations to convince me, as the first non-PCDD, to accept the position. My relationship with the 59th CDD goes back to when he was the Executive Director for the MCL. My company assisted in moving the League's HQ to its new location by wiring the office space for data and setting up the security cameras and access controls for HQ. I hope the trust and confidence he placed in me then played a part in his decision to ask me to take this position.



Shortly after accepting the position, it became obvious how much work needed to be done. In February, the Chief and I traveled to Connecticut to meet with PCDD Fisk. We began taking the steps necessary to consolidate our banking and finances. It also became obvious what a terrific job our Honorable Kennel Quartermaster and Honorable Kennel Dog Robber are doing. They work crazy hours on behalf of the Kennel and you the membership.

One of my first decisions as the ED was to immediately streamline the banking issues regarding the handling of checks from the Packs and Pounds. With the concurrence of the Chief, other new banking procedures are being implemented as I write this article. The Dog Robber will soon have a check scanner that will immediately deposit checks and this will help you balance your books quicker. The scanner will also identify any check with insufficient funds, and this will save us money in bank fees.

The goal is to make the Quartermaster's job easier while again saving money for the Kennel. I fully recognize the time and effort our Quartermaster puts in and can't thank her enough for working with me. The goal is to eventually have a fully integrated eCommerce section on our new and improved website. (More on that later.)

Woof, woof to all MODD Kennel Staff members and to all Members of the Order. As many of you are aware, the recent outbreak of the COVID-19 (commonly called Coronavirus) and how it is affecting our Country has been dominating the news across the Country. Various stages of precaution have been issued by the World Health Organization (WHO) and the Center of Disease Control (CDC). I would be remiss if I were to ignore these constantly updated warnings and not state my professional opinion and advice as both your Chief Devil Dog and as a Marine.

The warnings being provided by the CDC recommend that Americans should avoid large group congregations of people; what was defined as being 100 or more people a week ago, has now been lowered to 50 by the CDC. No matter what our opinion is of the Media, which in many of our opinions has caused Nationwide panic, the CDC has set guidelines with the safety of everyone considered. As much as I wish to travel to the Division Conferences, the Pack and Pound Growls taking place over the next few weeks, I must advise against these conferences and Growls taking place. I feel we owe it to our membership to look out for their health and welfare and not ignore the warnings of the agencies who are providing these medical guidelines.

I recently read the letter sent out from the Marine Corps League National Commandant and in the very first paragraph, he states, "The Marine Corps League has the responsibility and obligation to ensure that our membership and their families have the safest environment possible". This recommendation from our Commandant should not be taken lightly and for us to risk the safety of even one member is not worth the pain or suffering should another group be exposed to this disease. This is a disease that is new to the books when it comes to humans. It is as it has been proven deadly to personnel who have prior respiratory problems as well as to other groups of people.

Schools across the Country have been closed for several weeks in an attempt to control the spread of exposure. Workplaces have closed their doors, restaurants and stores have closed. All this to follow the CDC's guidelines and suggestions on how to avoid the spreading of the virus.

I ask that you consider the rescheduling or cancellation of our events in order to comply with the CDC guidelines. Our Military installations have been placed on alert status, State and Local Government agencies have placed restricted work requirements in many areas of the Country. This is not to be taken lightly; I urge you to reconsider holding your larger scale Conferences and Conventions; let's consider the health and safety of our members and avoid large scale meetings in accordance with the Center of Disease Control. Let's do our part to minimize the effects of this virus so that we can live and fight another day.

SUBJECT: GUIDANCE DURING COVID-19 PANDEMIC

As our Nation continues to deal with the COVID-19 (Coronavirus) pandemic, our National, state, and local leaders are taking more stringent actions in order to prevent Americans from facing the same numbers of infected as seen in other countries around the world. As a result, the Chief, Board of Directors, and I are aware that Pack and Pound Growls will have to be canceled in order to keep members of the Order safe. These cancellations are fully supported by us as this is a highly contagious virus which can be extremely dangerous to those who contract it.

Chief Hazlett wants to ensure all Devil Dogs who are attempting to advance degrees will not be held back due to these cancellations. This applies to those Pups and Devil Dogs who have been attending growls before the COVID-19 outbreak in order to achieve their next Degree but cannot meet the required number of growls as a result of quarantines or cancellations. I ask that all Pound Keepers and Pack Leaders use their best judgement when exempting Dogs from this requirement for advancement. Do not hold enthusiastic Dogs back from advancement due to a situation none of us can control.

If any Packs or Pounds need to delay elections and installations of new officers due to the COVID-19 pandemic, we can assess those situations. Most likely, an extension will be granted as no one is certain how long we will need to limit gatherings and be cautious.

This is an unprecedented event for all of us. We want to ensure all our members that no Dog, Pack, or Pound will be chastised or held back as a result of the current situation. We are here to support you, work with you, and ensure that you are taking actions to protect your health. Please follow local guidance, check in on your fellow Dogs, and stay safe.

10 ways to manage respiratory symptoms at home

If you have fever, cough, or shortness of breath, call your healthcare provider. They may tell you to manage your care from home. Follow these tips:

- 1. Stay home** from work, school, and away from other public places. If you must go out, avoid using any kind of public transportation, ridesharing, or taxis.



- 2. Monitor your symptoms** carefully. If your symptoms get worse, call your healthcare provider immediately.



- 3. Get rest and stay hydrated.**



- 4.** If you have a medical appointment, **call the healthcare provider** ahead of time and tell them that you have or may have COVID-19.



- 5.** For medical emergencies, call 911 and **notify the dispatch personnel** that you have or may have COVID-19.



- 6. Cover your cough and sneezes.**



- 7. Wash your hands often** with soap and water for at least 20 seconds or clean your hands with an alcohol-based hand sanitizer that contains at least 60% alcohol.



- 8.** As much as possible, **stay** in a specific room and **away from other people** in your home. Also, you should use a separate bathroom, if available. If you need to be around other people in or outside of the home, wear a facemask.



- 9. Avoid sharing personal items** with other people in your household, like dishes, towels, and bedding.



- 10. Clean all surfaces** that are touched often, like counters, tabletops, and doorknobs. Use household cleaning sprays or wipes according to the label instructions.

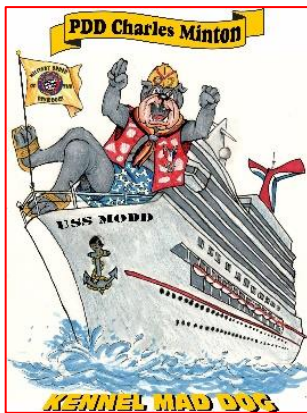

The DD initiation activities are shaping up nicely. We have several activities planned for the advancing Dogs, all

DD's who are advancing need to make sure you have appropriate beach/pool attire, you're going to be needing it. We have a beach activity with a NASCAR theme, a scavenger hunt which will help the Dogs to learn their way around the unfamiliar territory, Mad Dog says so we can make sure all the initiates can follow orders and last but not least, we have the Chief's first ever Doggy paddling sled team at one of the pools (you don't want to miss this one). 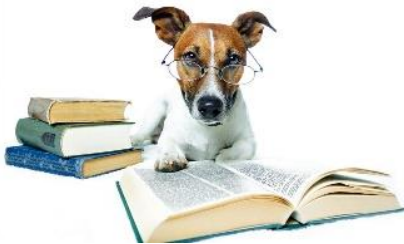

It is that time of year again when anyone wishing to advance to PDD at the Supreme Growl in Daytona needs to get their request to me. They must be in my hands prior to **July 1**. If the Advancement papers are not in on time, you may be denied the opportunity to go through initiation and be obligated as a PDD. Please remember that the **Pack Dog Robber** must sign the request for advancement and that a copy should be kept by the Pack, Pound and by the individual Dog. Please bring your copy of the request with you as insurance against anything going wrong.

Please remember that the bylaws have changed. You must be in attendance by 5:00 PM on Monday.

Passport funds continue to arrive with many more Pounds contributing. However, there are still way too many Pounds and Packs that have not sent in their Bones. Pounds and Packs are required by the By-Laws to hold at least 4 Growls per year. If you are holding the required Growls, then the fee for stamping the passports should be sent in. The Children's Hospital in Daytona will be very grateful for your contribution.

I continue to receive Installation Reports with dates other than Sept through Nov. The By-Laws state that Pound elections are to be held within that time period. **We are not the same as the League.**

All Packs and Pounds should be incorporated in order to protect themselves and to allow them to legally collect donations. Each should also have a EIN number from the IRS and be filing 990 forms annually. Send the information to the Kennel Dog Robber. If you do not file your taxes the IRS will revoke your tax-exempt status. Trust me, you do not want to go through the hassle of all the paperwork and time to get re-established as a tax-exempt organization. There is a new version of the Installation Report on the Kennel web site. Please use them.

We will no longer keep or send out hard copy forms. The only ones that will be available will be on the web site. Use those forms.

Many members have still not renewed their membership for 2020. **Dog Robbers: Please follow up on this and get them paid!**

Up to date manuals and forms are available on the website. Please make sure you are using current versions of the By-Laws, Dog Robber manual and forms.

Like to recommend the following Proposed Bylaw Change for consideration.

Article I Section 103 – Election, Notification, Obligation and Rejection;

Currently Reads:

Election

A. Under the Order of Business "Election of Candidates" the Unit Dog Robber shall read all applications for obligation and initiation, certifying as to their correctness and as to the amount of membership dues and/or election fees accompanying each application.

1. Voting shall be by secret ballot, either by a show of hands or written, and shall be under supervision of the Smart Dog and Police Dog, with the Pound Keeper, Worthy Pack Leader, or Honorable Chief Devil Dog (the presiding officer having jurisdiction) confirming the results of the ballot.
2. It is permissible to vote for the candidates as a group. When the vote is taken for the group, a simple majority will determine the acceptance or rejection of the group. Rejection shall require a ballot for each and every candidate.

Notification

B. The Unit Dog Robber shall promptly notify all successful candidates of the time and place for obligation and it shall be the duty of the candidates to be present.

1. Should the successful Pup candidate fail to appear at two successive Growls of the Pound without just and valid reason, the approval shall be

withdrawn, the membership dues refunded and the election fee forfeited to the Pound. They shall not be eligible for approval for a period of six calendar months from the last Growl of the Pound to which they were instructed to appear. They shall also be required to pay their proper membership dues and election fees.

2. Should the successful Devil Dog candidate fail to appear at the Growl of the Pack or the Grand Growl of the Pack to which they were instructed to appear, the approval shall be withdrawn and their election fee forfeited to the Pack. They will not be eligible again for obligation and initiation until one calendar year has elapsed or until the next succeeding Grand Growl of the Pack, whichever shall be last occurring, and the payment of a proper election fee.

3. Should the successful Pedigreed Devil Dog candidate fail to appear at the current Supreme Growl, the approval shall be withdrawn and their election fee shall be forfeited to the Kennel. They will not be eligible for obligation and initiation until the next succeeding Supreme Growl of the Kennel and the payment of a proper election fee.

Obligation

C. Any successful candidate, having appeared at the time and place fixed for the assembly of the Growl of the unit of obligation and initiation into the Degree called for in their application, shall be initiated under supervision of the Unit Mad Dog into the mysteries of said Degree in accordance with the traditions of the Order and after the initiation, shall be obligated to the Degree as set forth in the Ritual of the Military Order of the Devil Dogs Inc., by the Unit presiding officer or by any past presiding officer of a superior unit.

Rejection

D. Should the application of any candidate be rejected by the Unit to which the application has been made, the election fees and in the case of the application for the Degree of Pup, the membership dues accompanying the application shall be immediately returned to the applicant by the Unit Dog Robber and the name of the rejected candidate cannot again be presented for consideration for such a period as may be applicable under paragraph B-1, B2, and B-3 of this section.

Unit Dog Robber

E. It shall be the duty of the Unit Dog Robber to place the date and over their signature, certify as to the disposition made of the application. The original papers shall be retained in the files and copies of the application, duly certified and signed, be forthwith sent to the Dog Robbers of their superior and/or junior jurisdiction.

Change to Read:

Election

A. Under the Order of Business "Election of Candidates" the **Pound/Pack/Kennel** Dog Robber shall read all applications for obligation and initiation, certifying as to their correctness and as to the amount of membership dues and/or election fees accompanying each application.

3. Voting shall be by secret ballot, either by a show of hands or written, and shall be under supervision of the Smart Dog and Police Dog, with the Pound Keeper, Worthy Pack Leader, or Honorable Chief Devil Dog (the presiding officer having jurisdiction) confirming the results of the ballot.

They shall not be eligible for approval for a period of six calendar months from the last Growl of the Pound to which they were instructed to appear. They shall also be required to pay their proper membership dues and election fees.

5. Should the successful Devil Dog candidate fail to appear at the Growl of the Pack or the Grand Growl of the Pack to which they were instructed to appear, the approval shall be withdrawn and their election fee forfeited to the Pack. They will not be eligible again for obligation and initiation until one calendar year has elapsed or until the next succeeding Grand Growl of the Pack, whichever shall be last occurring, and the payment of a proper election fee.

6. Should the successful Pedigreed Devil Dog candidate fail to appear at the current Supreme Growl, the approval shall be withdrawn and their election fee shall be forfeited to the Kennel. They will not be eligible for obligation and initiation until the next succeeding Supreme Growl of the Kennel and the payment of a proper election fee.

Obligation

C. Any successful candidate, having appeared at the time and place fixed for the assembly of the Growl of the **Pound/Pack/Kennel** of obligation and initiation into the Degree called for in their application, shall be initiated under supervision of the **Pound/Pack/Kennel** Mad Dog into the mysteries of said Degree in accordance with the traditions of the Order and after the initiation, shall be obligated to the Degree as set forth in the Ritual of the Military Order of the Devil Dogs Inc., by the **Pound/Pack/Kennel** presiding officer or by any past presiding officer of a superior **Pound/Pack/Kennel**.

Rejection

D. Should the application of any candidate be rejected by the **Pound/Pack/Kennel** to which the application has been made, the election fees and in the case of the application for the Degree of Pup, the membership dues accompanying the application shall be immediately returned to the applicant by the **Pound/Pack/Kennel** Dog Robber and the name of the rejected candidate cannot again be presented for consideration for such a period as may be applicable under paragraph B-1, B2, and B-3 of this section.

Pound/Pack/Kennel Dog Robber

E. It shall be the duty of the **Pound/Pack/Kennel** Dog Robber to place the date and over their signature, certify as to the disposition made of the application. The original papers shall be retained in the files and copies of the application, duly certified and signed, be forthwith sent to the Dog Robbers of their superior and/or junior jurisdiction.

All applicants for Initiation to the Degree of Pedigreed Devil Dog, Devil Dog and Pup at the Supreme Growl, in accordance with Article I and Subparagraph 416 C of these Bylaws, must register first with the Marine Corps League, Inc., and then immediately proceed to the Kennel Dog House and register for the Supreme Growl and initiation. This registration must be completed **no** later than 1700 **two days** prior to the Supreme Growl. Anyone not registering by 1700 **or at least in line to register on that day will not** be initiated during the Supreme Growl without the express approval of the Honorable Chief Devil Dog, the Honorable Kennel Dog Robber and the Honorable Kennel Mad Dog **on an individual case by case basis**. Packs and Pounds holding Growls and Initiation concurrently with Marine Corps League organizations (Divisions, Departments, etc.) should include similar provisions within their Bylaws, which are consistent with the local requirements and scheduling.

Change to Read:

All applicants for Initiation to the Degree of Pedigreed Devil Dog, Devil Dog and Pup at the Supreme Growl, in accordance with Article I and Subparagraph 416 C of these Bylaws, must register first with the Marine Corps League, Inc. **Recommended Prior to 1500** and then immediately proceed to the Kennel Dog House and register for the Supreme Growl and initiation. This registration must be completed **NO** later than 1700

Two days prior to the Supreme Growl. Anyone not registering by **1700 or at least in line to register on that day will not** be initiated during the Supreme Growl without the express approval of the Honorable Chief Devil Dog and the Honorable Kennel Dog Robber and the Honorable Kennel Mad Dog **on an individual case by case basis.** Packs and Pounds holding Growls and Initiation concurrently with Marine Corps League organizations (Divisions, Departments, etc.), should include similar provisions within their Bylaws, which are consistent with the local requirements and scheduling.

Rational:



In the event of the dissolution or final liquidation of the Order, the remaining net assets shall be distributed to such nonprofit corporations or associations as are exempt from Federal Income Tax under Section 501 (c) of the Internal Revenue Code, as the Board of Trustees in the exercise of its discretion may determine, and no part of such net assets may inure to the benefit of any individual member or person,

Change to read

Section 1213 - Dissolution

Upon the dissolution of the corporation or the organization, the Board of Directors or governing staff shall, after paying or making provision for the payment of all of the liabilities of the corporation or organization, dispose of all the assets of the corporation or organization in such manner, or to such organization(s) organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization(s) under section 501(c)(3) of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue Law), as the Board of Directors or governing staff shall determine. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation or organization is then located, exclusively for such purposes as said Court shall determine, which are organized and operated exclusively for such purposes.

The following Change and rationale is submitted for Article II, Section 205.

ARTICLE II - POUNDS - Section 205 - Growls - Regular, Annual, Special and Staff

Currently reads:

A. REGULAR - Each Pound shall hold no less than **four** regular assemblies during any fiscal year, which assemblies shall include the annual assembly of the Pound, for the election of officers.

Change to read:

A. REGULAR - Each Pound shall hold no less than **two** regular assemblies during any fiscal year, which assemblies shall include the annual assembly of the Pound, for the election of officers.

Rationale:

1st - Our Pound covers the whole Upper Peninsula of Michigan, in addition to the Northern part of the Lower Peninsula of Michigan, an area "In excess of" .. 16,377 square miles just for the U.P., plus the additional area in the Lower Peninsula. This makes travel to the Pound Growl a "planned" event, not a quick, spur of the moment trip. From the East End of the U.P. to the West End is about.. 225 miles. We have found that having two growls, allows us to function well, plan what we need, and complete our tasks. *(Two mileage examples for us are: The one-way travel to the growl, at present for the Pound Keeper is about 66 miles, and the current Smart Dog about 112 miles, other members' mileage within the Upper Peninsula are similar. This is with a centrally located place for the growls, agreed on by the members.)* We also understand there are other pounds with similar circumstances.


2nd - There already is a written exception to this requirement in the Kennel bylaws.

This is in:

ARTICLE II - POUNDS Section 201 - Definition

- C. 2. as "Name of the State" Pound..... *"and by reason of the wide geographical residency of the membership making it difficult to hold a "called" or "stated" Growl of the Pound, it shall be in order for such a Pound to convene any Growl of the Pound, only in concert with a Convention of the Marine Corps League, Inc."*

RATIONALE:

By existing by-law "Section 605-Stray, A stray shall be any member of the Order, who for good and proper reason, cannot be attached to any functioning Pound. "

Strays do not pay dues to Pounds or Pack, therefore they are not In Good Standings to either a Pound or Pack. Strays belong to the Kennel only, and are on the roster of the Kennel and are NOT on Pound or Pack rosters.
