

By the time you read this, we will be in the middle of summer and most of our Divisions will have completed their conferences. The Packs will have held their annual Grand Growl of the Pack and forwarded their Passport and stamping fees to the Kennel. Now that these administrative functions are completed, it's time to start focusing on heading west to Billings, Montana for the Supreme Growl. Are you all ready to get off the porch, head out there and share in the fun and banter that Marines are famous for? The Devil Dogs create the fun when they arrive and there's nothing better than getting into the mix and enjoying meeting new Devil Dogs who are moving up to Pedigree. Many of these help create some skits that allow us to howl at their antics. Always keep in mind that if you have medicine

you take daily to pack it and take it as you travel to the Growl. Plus, if you have any special items that you need to help you get around, bring them too. If you need oxygen packs, please ensure you have all what you need for your trip. If you have a motorized wheelchair, ensure you have it checked or bring a back-up charger in case you need it. Nothing worse than arriving somewhere and realize you forgot your medication and your cane or walker. If you are driving a vehicle for multiple long hours, stop every few hours, take a few minutes to rest and stretch your legs. If you take blood thinners or have varicose veins, it's extremely important to stop and rest to help you avoid blood clots. When you arrive in Billings and have some special medical problems, look up one of the Kennel Veterinarian staff members and pass on your information. There are certain conditions where you should not travel, and I'll name a few: recent heart attack, recent cardiac bypass surgery, new seizure disorder, neurological conditions with problems standing or walking, uncontrolled diabetes, recent stroke, recent head trauma with unconsciousness, and broken leg in a long cast and on use of crutches. There are multiple others and I won't mention them, but please do not place yourself at risk when traveling to the Supreme Growl. Take care of yourself, bring some fun with you and I'll see you in Billings, Montana.

WV Pack member finds lost daughter

The members of the WV Pack did a huge amount of howling during the recent Grand Growl of the Pack. During the Growl, PDD Greg Irwin brought an issue to the floor for consideration. He had been dating a beautiful model named "Rachel" that he met in a department store. They dated for 2 years and became engaged. She wanted her biological father to walk her down the aisle and did not know who he was. Her mother had

told her that her father was an American Peace Corps Volunteer that she met many years ago in the Congo and did not know his name. The Pack Leader fined Irwin several bones for bringing a female



(continued) civilian and the issue to the Growl. The Pack had done some extensive research and narrowed the father down to three Dogs present in the Growl.

The daughter asked the members to decide who her father was after each one presented their story:

PDD Wayne Sarapata was in New York City during Fleet Week many years ago and attended a ship party and got wasted. He walked to Central Park and sat on a park bench watching the pigeons and a yellow parrot. The parrot kept jumping up on his shoulder talking Spanish to him and he kept pushing it away, but it continued to jump on him. He passed out and woke up the next morning and noted yellow feathers all around him. He hated to admit it, but he was very lonely and may have ravished the parrot. The Pack Leader fined him for possibly ravishing the parrot.

PDD Lee Taylor used to drive a bus in Baltimore and moonlighted as a Chippendale dancer on weekends and special occasions. One weekend he was asked to perform at a Convention of truck driver wives near Winchester. After starting his routine, a bunch of male truck drivers burst into the room, grabbed him and carried him outside. They stripped his costume off and threw him into a nearby field. He had been knocked out and woke up buck naked, surrounded by a bunch of sheep. The owner of the herd saw him standing among his animals and thought the worse and started shooting at him. Lee ran as fast as he could and jumped over a fence injuring both legs which bother him even today. He was injured so bad, he quit dancing and went back to driving the bus. The village Chief took this opportunity to get his daughter and PDD Kirby together. They stayed together for several months while he suffered from amnesia. The villagers were digging a well for another village and he went with them. After arriving at the well site, a tree limb fell striking him on the head and shoulders. He was knocked out and the medicine man looked at him and determined he had another concussion and his amnesia had cleared up. He did not remember anything from the last concussion and this included the Chief's daughter. This made the old Chief angry and had the potential to cause an International incident. The Peace Corps returned Kirby from the Congo to the U.S. and dismissed him. The Pack Leader fined him for his failure to keep in contact with the Chief's daughter.

After these stories were presented to the Dogs, they voted PDD Kirby as the biological father. He jumped up claiming he was framed and wanted a lawyer. The Pack Leader fined him and every Dog who voted for him. He fined all the other Dogs for not listening to the stories and himself several times when he lost control of the Growl. It was noted by the Kennel Vet PDD Roger Ware that the Pack Leader fell asleep several times during the stories and was worried that the Pack Leader was getting whip lash. He was fined several bones for squealing.

PDD Kirby stated since he was the Pack Smart Dog he would defend himself. The Pack Leader fined him for being so intelligent. His whole defense was based on his amnesia during the time Rachel was conceived. His amnesia had returned, and he could not prepare a defense as he could not recall anything. He was fined again by the Pack Leader. PDD Rick Shank representing PDD Irwin and Rachel stated the defense PDD Kirby prepared had to be thrown out and for the Pack Leader to declare that Rachel be confirmed as his daughter. (continued) PDD Kirby said since he had another daughter, he might as well adopt PDD Irwin and Irwin would be his son. When Irwin marries Rachel, he will be marrying his sister and she will also be his wife. The whole skit created \$422 large bones and was added to the passport fees. Some of this story is true but since a few of our Dogs are in the federal witness protection program, we cannot mention their names.

By the time you get this it will be too late to get your advancement application in. Sorry! See you next year in Florida.

At the Supreme Growl awards will be given out. To date I have only 3 submissions. I am very disappointed. It looks like no one in the Pounds think any of their Dogs do

anything or are worthy of being recognized. This has been the trend over the last several years and I think it is pitiful. Awards are about the only way someone can be thanked for all of the effort they put in for the good of the Order. There is still time to get your submission in. They will be accepted until noon of the day prior to the Growl. Let's get those nominations in! **Please make sure you follow the instructions in the by-laws on mailing**. Otherwise the committee cannot consider the application.

Now for some good news, the top 8 contributors to the **Passport Fund are: Pd 370 NC \$3,408.46, NC Pack \$2,884.30, Pd 350 GA \$2,389.25, GA Pack \$2,268, Pd 333 MD \$1,738, PA Pack \$1,984.25, Pd 204 MD \$1,312, MO Pack \$1,198.27.** In addition, there were a couple of noteworthy contributions made. **The Big D Detachment of TX \$1,000, and the NE Division \$1,000**. Their outstanding support is greatly appreciated.

The new fiscal year begins July 1 and I will begin accepting dues renewals for the 2020 year at that time. All Dog dues should be renewed by September 1 to be in compliance with the by-laws. On Sept 1, I will drop from the rolls all Dogs that have not paid their dues for 2019. After that date, you will be required to pay back dues and a reinstatement fees to get back in good standing.

I keep getting Installation Reports throughout the year. **Elections and Installation of new Officers is to occur within three months after the Supreme Growl**. If you are holding your election and installation at other times of the year, you are in violation of the by-laws.

Passport fees continue to come in and they are much appreciated. More Pounds and Packs are doing their job and sending in their bones. The Children's Hospital that is selected in Billings will be very happy with the donation we are going to give them. Some Pounds and Packs continue to neglect this important area. I encourage each Dog to check with their Dog Robber and ask if he has sent in the required stamp fees. We want the donation to be the largest ever.


