Application for Degree Advancement



- Filling out the Application for Degree Advancement correctly is instrumental in assuring that your Dogs are advanced when they are qualified.
- Follow the Directions in the MODD Dog Robber Manual.
- MCL Membership Number, NOT PLM Number.
- Applications for Pups advancing to DD must be signed by the POUND Dog Robber.
- Applications for DDs advancing to PDD must be signed by the PACK Dog Robber.
- Make sure the Applicant lists any physical problems that might be of concern for the initiation. If none exist, write "NONE."
- Don't forget to have the applicant sign and date the Application!
- The signature blocks for MAD DOG, WITNESS and DATE OF INITIATION will be blank until AFTER the Initiation and Obligation.
- Follow the Form Distribution instructions.

This application must be accompanied by a Charter Fee of \$20.00 (By check or money order, payable to Kennel MODD); signed by seven (7) members of the Order, five or more of whom shall be Devil Dogs or Pedigree Devil Dogs and a list giving name, address, and license number of all applicants. Applicants must be in good standing, both in the Marine Corps League and the Military Order of the Devil Dogs. Remittance can accompany the application to place applicants in good standing in the Order and must include dues for the current year. When application is granted, the original will be returned by the Honorable Chief Devil Dog, a copy filed with the Hon. Kennel Dog Robber and a copy filed with the Worthy Pack Leader.
