## GROWLINGS FROM THE 58TH CHIEF DEVIL DOG

WOOF-WOOF to all Dogs of the Order,

Many big bones were collected, so we are at 50% of our goal for our donation to the Children's Hospital needs in Billings this summer. Here is what else was accomplished.





First of all, we had an excellent

Memorial service to honor those Dogs who passed during the last six months. The Honorable Kennel Dog Trainer wrote and presented a very moving memorial program, that brought many Dogs to tears. We especially mourn the untimely passing of our Rocky Mountain Division VCDD, Phillip Price. Thank you PDD Jason Rowell, for the outstanding tribute.

Kennel Officers announced their

intentions to seek positions at the Supreme Growl in Billings. SVCDD Tom Hazlett seeks the position of Chief DD, and JVCDD Alan Sanning seeks to advance to SVCDD. PDD J.D. Jones announced for JVCDD. Two Dogs, PDD Tom Krueger and PDD Evelyn Remines, both announced to run for the position of Kennel Smart Dog.

The Kennel Smart Dog reported that there are five proposed amendments to the bylaws. These proposed amendments can be found elsewhere in this issue of the WOG.

It was my honor and privilege to present checks to the Marine Corps Youth Foundation, the MODD Fleas, and Operation Little Angels, in the amount of 1250 Big Bones each, on behalf of the Order.

In the Dog House, my excellent staff kept everything running smoothly. Registration was a breeze, thanks to good help at the registration table. Thanks to the Kennel Watch Dogs and Kennel Police Dogs, for ensuring that only those eligible to enter were so allowed, and for collecting lots of Big Bones. Also, there is no more valuable member of the Kennel Staff than PDD Terry Hightower, our Kennel Koncierge, who made sure that signs were posted so that all Dogs could find their way to the Kennel. Kennel Lucky Dog PDD Evelyn Remines and her Deputies sold lots of raffle tickets as always. If I missed anyone, I apologize. You are all important Dogs of the Kennel. Thanks for your hard work and dedication. I could not do it without your help.

While presenting my report at the Mini-Growl, I announced that I had an idea for a summer fundraiser. This is what I had in mind ... Last June we celebrated the 100th anniversary of the battle of Belleau Wood, during which the defeated German soldiers honored the Marine Corps' ferocious fighting by naming us "Teufelhunden" or Devil Dogs. So I ask, do we really need to wait another hundred years to celebrate again? Woof No!!

(continued) We, as current day Devil Dogs, continue to exhibit that fighting spirit which has been displayed by all Marines over the years. While not on a battlefield, we have found new challenges within our communities that we agreed we can all get behind. One of these challenges is helping to make a difference in the lives of children. We are protectors and we have chosen to help the children of the cities in which we gather. With this in mind, we have an opportunity to have some fun, let the public know who we are, and raise some money for the children.

What I am proposing is that, in the month of June, we hold another birthday party! This time, make it an opportunity for your Pound to get together with a local group (preferably something dog-related) such as the humane society, a local dog groomer, or pet store. Be creative. You can have a pet costume contest, sponsor a BBQ and take donations, or whatever else your local laws will allow.

As previously stated, this gets our organization out there in the community, but it is also a way to raise money for the kids. The timing of this event is perfect for one last opportunity to raise money for the Kennel's big donation for the children's charity at the Supreme Growl, as the Big Bones need to be turned in before July 1st.

This is an event that has the potential to be an ongoing activity that could be done each June, as well as to be a great recruiting opportunity for the MODD and the League. I hope you will give it serious consideration. You have plenty of time to make this happen. Feel free to send me your progress reports. Just have FUN with the Dogs of your Pound! Remember, it's for the kids. Elsewhere in this WOG, you will find information about the main fundraiser for the Kennel. It's the Jr Vice CDD's Sweepstakes program, and the tickets will be found in this WOG. Please use them, get them mailed in as soon as possible, and get involved just a little bit. You could be the big winner!

Finally, if you plan to advance at the Supreme Growl in Billings, MT, get your application submitted to your respective Pack Dog Robbers ASAP. Applications must be in the paws of the Kennel Dog Robber no later than 01 July 2019 ... NO EXCEPTIONS! Once you have submitted the required information, check the Kennel website under "Growl Info". If you don't see your name listed there within a few weeks, you need to check with your Pound Dog Robber and/or your Pack Dog Robber to make sure they have forwarded the paperwork. This is your responsibility, and there will be no exceptions after the deadline is passed. And don't forget to keep a copy of your paperwork and bring it with you to Billings. These steps will ensure that you will get to participate and advance as planned.

Please continue your recruitment and retention efforts. We need more Dogs to help accomplish our goals. Also, remember to keep me in the loop as to what is happening in your Pound or Pack.

Be on the lookout for some worthy MCL members who would be assets to the Order!



issue. You can monitor the list on the Kennel website under Growl Information; a complete list of all paperwork processed by the Kennel Dog Robber can be found there.



Woof-Woof Dogs of the Kingdom,



#### KENNEL VET



The Dogs had some good fun at the Mid-Winter Mini Growl in Fredericksburg, Va., and it was really good to see some of the elderly, grizzled Dogs mixed in with some of the younger ones. We all had one goal in mind ... just get together and share in some fun and antics. Good humor keeps you young and that can also work with taming your Mama Dog. It won't be too long until our Supreme Growl in Billings, Montana, so it's time to get focused and get your gear in one sock. Any Dog who needs medicine for any reason needs to ensure they bring those pills with them and take that medicine daily. In addition, if you use a cane or other device to assist you with walking be sure to pack it too. Those with motorized wheelchairs need to ensure your battery pack is ready to go.

Your Kennel Veterinarian staff will be at the ready for any Dog that needs medical assistance. Veterans who wear a medical ID's need to let your Kennel Veterinarian staff know your medical conditions that warrant your having a tag. Wearing a medical ID protects against potentially harmful medical errors and eliminates unnecessary trips to the hospital. It is easy to claim your Veteran medical ID with the help of your clinician. Download and print the VA information sheet to bring to your VA clinician.

A medical emergency can occur anywhere and may not involve you but can happen to a loved one or a bystander. We tend to not worry about an emergency as we all believe it will not happen to us, so we let it go. Do you really know what to do or how to take action? Can you take steps to save a life? Here are some common emergencies, so cut this out and place several copies around your home, in your car or even in your wallet. It doesn't do any good if you leave it at home while you are on the road. The following is for use at a Supreme Growl but can be modified to your location.

#### What to do in a Medical Emergency

Can they speak or are they unconscious?

Call 911

Secure the area – ensure safety of yourself and others

Contact Kennel Medical staff

Contact hotel security/front desk

Get the automatic external defibrillator (AED) on site

**<u>Heart attack</u>**: Do they have: chest pain, jaw pain, shortness of breath, nausea

Sit down, give 4 baby aspirin to chew

Cardiac Arrest: start CPR, get AED

**Stroke**: FAST protocol

Facial drooping, Arm weakness, Slurred speech, Time to call emergency services

(continued) **Seizure**: lie down, protect head, time seizure, lie on side after seizure

**<u>Diabetic shock</u>**: If conscious did they take their medication,

if confused give something sweet to eat or drink

**Faint**: lie down, squeeze their hand, cross their legs have them squeeze their thighs.

The Veterinarian staff is looking for some new medical staff members. Are you a Medical Corpsman, Physician, EMT or Nurse and want to join the Veterinarian staff? We need some warm furry Dogs to help us at the Mid-Winter Mini and Supreme Growl. If you want to join our team, contact the Kennel Veterinarian staff listed on the Kennel staff roster at moddkennel.org

Stay safe, watch out for each other and I hope to see a whole pack of Dogs in Montana. Come on out and bring some Dogs with you and share in the Fun and Honor Society of the MCL. Seek out some new members for your Pound and mentor them so they can bark louder than anyone in your Pack. You cannot get famous staying on your porch all chained up, so break loose and come join us. Hopefully none of our Dogs will get rabies in Montana.

Packs and Pounds holding Growls and Initiation concurrently with Marine Corps League organizations (Divisions, Departments, etc.) should include similar provisions within their Bylaws, which are consistent with the local requirements and scheduling.

This registration must be completed **NO** later than 1700

Change to read

Section 108: Reinstatement

B. Any member of the Order not in good standing and/or who have been dropped from the membership rolls of the Order for ANY CAUSE shall not be eligible to wear any emblems, insignia, sign or uniform of the Order until and unless they become a member of the Order in good standing. Any member upon reinstatement after being suspended from the Order must serve at least one year as a contributing member in good standing before being recommended for elevation to the next higher degree.

Rationale: There is no procedure in the Bylaws for the reinstatement of a member who has been suspended. Adding the second sentence to Section 108 paragraph B will give some guidance for members for reinstatement. Requiring them to serve one year as a member in good standing before they can be recommended for elevation to the next higher degree gives the reinstating Pound time to observe the member before making their recommendation

# ARTICLE VII -UNIFORM

Section 702 - Devil Dog Uniforms

#### Current Bylaw:

Section 702- Devil Dog Uniforms- The official uniform of the Military Order of the Devil Dogs shall be as follows:

- A. An embroidered official insignia may be worn on the right sleeve of the shirt, with the top of the insignia one and one-half  $(1 \frac{1}{2})$  inches below the shoulder seam.
- B. Shirts worn as party of the uniform shall be white. The sunburst insignias will be worn centered on the collar. MCL ribbons or USMC ribbons may be worn, but NOT a mixture of both. Shirts bearing the embroidered official insignia and lettering of the Order on the back side may also be worn.
- C. Cap patch of the Military Order of the Devil Dogs, Inc, is to be sewn on the right hand side of the Marine Corps League cover, centered over the piping, (Gold piping on Detachment members and Department Officers cover, and the red piping on the National Officers cover); so that one half of the patch extends from either side of the piping. The eyes of the Bull Dog on the patch should be level to the "deck" and the Gold Trench helmet will be canted to the left side of the Bulldog's head. The bottom line of the helmet touching the Bulldog's head on either side should be parallel to the piping on the cover. No pins, stars, medals or any other devices shall be worn on the official MCL Cover. Gold caps may be worn by Kennel officers, but they must revert back to the cap they are authorized to wear, after completing their term of office, in the Kennel. Only Past Chief Devil Dogs may wear the Gold cover after their term and the dates of tenure must be sewn on the cover. (See illustration at the end of the Ritual). Past Worthy Pack Leaders may wear their Department covers after their term in office, with the dates of their term sewn on.
- D. The individuals name and Pound number may appear above the left pocket of the white shirt and the Officers title may appear above the right pocket with the length of the letters not to exceed three Quarters of an inch (3/4). Letters must be all one color, gold, red or black.
- E. Dress blues trousers w/NCO red stripe or black trousers may be worn with the Devil Dog white shirt uniform.

#### Proposed Change:

The official uniform of the Military Order of the Devil Dogs, Inc. shall be as follows:

- A. The cap patch of the Military Order of the Devil Dogs, Inc., is to be sewn on the right-hand side of the Marine Corps League cap, centered over the piping, (gold piping in the Detachment member cover and the Department Officer cover, red piping on the National Officer cover); so that one-half (1/2) of the patch extends from either side of the piping. The eyes of the Bull Dog on the Patch should be level to the "deck" and the Gold Trench Helmet will be canted to the left side of the Bull Dog's head. The bottom line of the helmet touching the Bull dogs head on either side should be parallel to the piping on the cover. No pins, stars, medals, or any other devices shall be worn on the cover without the official approval of the Kennel. Gold caps may be worn by Kennel Officers, but they must revert to the cap they are authorized after their term of office with the exception of the Chief Devil Dog. Past Chief Devil Dogs are authorized to wear the Gold with Black Crown Cover with red piping. The dates of tenure must be sewn on the cap in red lettering.
- B. The appropriate dog collar with dog tag: Black for Pup, Red for Devil Dog, Gold for Pedigree Devil Dog. The Chief Devil Dog collar shall be made of black, red, and gold. Pictures of collars and patches are below.
- C. In addition to the Cover, Collar and Dog Tag, the Marine may wear the red M.O.D.D. vest with appropriate patches affixed.

The optional uniform of the Military Order of the Devil Dogs, Inc. shall be as follows:

- A. An embroidered official insignia may be worn on the right sleeve of the shirt with the top of the insignia one and one-half (1-1/2) inches below the shoulder seam in place of the American flag, at the discretion of the Marine.
- B. Shirts worn as part of the uniform shall be white. The Sunburst insignia will be worn on the collar. MCL ribbons or DOD ribbons may be worn, but not a mixture of both.
- C. The individuals name and Pound number may appear above the left pocket of the shirt and officer's title may appear above the right breast pocket with the height of the letters not to exceed three quarters of an inch (3/4"). Letters must be all one color, gold, red or
- D. In place of the MCL cover, a Gold Beret with gold tassel and red lettering shall be optional headgear for all Pedigreed Devil Dogs while in that Degree.
- E. In place of the MCL cover, a Red Beret with a red tassel and blue lettering shall be optional headgear for all Devil Dogs while in that Degree.
- F. In place of the MCL cover, a Black Beret with a black tassel and white lettering shall be optional headgear for all Pups while in that Degree.
- G. Attached to the Beret shall be a Devil Dog shoulder patch, the affixing of which will indicate the front of the Beret.
- H. Lettering in colors indicated by "E", "F" and "G" of this section and appearing on the left side of the Beret shall indicate the office held and the dates of tenure and lettering on the right side of the Beret will indicate the Pound name and number.
- I. Marine Corps Dress Blue with red stripe or black trousers is required when wearing the white shirt.

At no time is the red M.O.D.D. vest to be worn over the White shirt and Marine Corps Dress Blue with red stripe or black trousers.

Rationale:

The current bylaws read that the white shirt with patches affixed are required, with or without optional embroidering of the Marine's name and Pound number and such.

All dogs attending growls with few exceptions are not in the required uniform; including the Chief Devil Dog. The majority of attendees wear the cover, collar with dog tag and the M.O.D.D. vest.

The current bylaws also read that "Marine Corps Dress Blue with red stripe or black trousers may be worn with the Devil Dog uniform." This would indicate that the wearing of either trousers or any trousers at all is optional.

This change would make the wearing of the MCL cover or optional beret with properly affixed MODD patch and the appropriate dog collar with dog tag the official uniform of the Military Order of the Devil Dogs, Inc. Wearing of the vest is optional.

The wearing of the white shirt would be optional, and Marine Corps Dress Blue with red stripe or black trousers would be required when wearing the white shirt. And as stated above, at no time would the red M.O.D.D. vest be allowed to be worn with the White shirt and Marine Corps Dress Blue with red stripe or black trousers.

Nomination letters may be hand delivered to the Honorable Kennel Dog Robber, in the Kennel Dog House at the Supreme Growl NO LATER than NOON, the DAY BEFORE the Supreme Growl. All such letters received by the Honorable Kennel Dog Robber shall be brought to the Supreme Growl,

sealed, unopened, and delivered to the Kennel Dog of the Year Award Committee Chairperson.

The Society will not accept any nomination which was not submitted and/or received as is stipulated herein.

# (7) Selection Process:

- a) The Chairperson of the Committee shall ensure that a current copy of the Kennel Bylaws is present during the deliberations of the Committee to ensure adherence.
- b) No member of the Committee may reveal to anyone not serving on the committee the names of the nominees, the discussions held regarding the worthiness or qualifications of the candidates, the ultimate selection or the criteria by which the nominations were judged.

The method of judging nominations shall be a majority vote of the Committee and shall adhere strictly to subparagraphs 5 and 6.

## (8) Awards:

The presentation to the selectee (Pound, Pack and Kennel) shall consist of the awards currently available through the Honorable Kennel Quartermaster. Pounds and Packs shall purchase their awards from that officer. The Kennel Dog of the Year award shall be purchased from the Honorable Kennel Quartermaster's account and retained by that officer until the award is to be made.

# (9) Time and Place of Awards:

Pounds and Packs shall establish their own timetable for presentations. The Kennel Dog of the Year Award shall be presented by the Kennel Dog of the Year Society at the Grand Banquet of the Marine Corps League National Convention.

Rational: The previous method of submission of a nomination letter had multiple areas that were not clearly explained. This revision is to clarify the submission process.

# Section 409 - Kennel Officers, Elected and Appointed Staff

- A. ELECTED The elected officers of the Kennel shall be: Honorable Chief Devil Dog, Honorable Senior Vice Chief Devil Dog, Honorable Junior Vice Chief Devil Dog, Honorable Kennel Smart Dog, Honorable Kennel Dog Trainer, Honorable Kennel Police Dog, and Honorable Kennel Mad Dog.
- B. APPOINTED After the election, the Honorable Chief Devil Dog-elect shall appoint an Honorable Kennel Dog Robber/Honorable National Executive Director, Honorable Kennel Watch Dog, and an Honorable Kennel Barking Dog, in such time as will permit their installation into office with the elective officers and these officers shall serve at the convenience and pleasure of the Honorable Chief Devil Dog.
  - It is preferable that the Honorable Chief Devil Dog-elect shall appoint to the office of Honorable Kennel Dog Robber/Honorable National Executive Director a Pedigreed Devil Dog who is experienced in the duties and responsibilities of the Dog Robber at either the Pound or Pack level.

# **Proposed Wording:**

# Section 409 - Kennel Officers, Elected and Appointed Staff

- A. ELECTED The elected officers of the Kennel shall be: Honorable Chief Devil Dog, Honorable Senior Vice Chief Devil Dog, Honorable Junior Vice Chief Devil Dog, Honorable Kennel Smart Dog, Honorable Kennel Dog Trainer, Honorable Kennel Police Dog, and Honorable Kennel Mad Dog.

The Order shall never be authorized to engage in a regular business of a kind ordinarily carried on for profit or in any other activity except in furtherance of the purposes for which the Military Order of Devil Dogs is organized.

Effective immediately, any Pack or Pound which has not provided the Honorable Kennel Dog Robber, with proof of its incorporation by January 1, 2018, will be billed in the amount of seventy-five (\$75.00) dollars and a like amount annually until such proof of Incorporation is on file with the Honorable Kennel Dog Robber. All fines will be forwarded to the National Headquarters, Marine Corps League, Inc. A Pound which fails to remit its payment to the Kennel Dog Robber shall be in default as is provided in Article Two, Section 218 – **POUND DEFAULT.** A new pound will have (2) years from the issue date of their new charter.

A Pound which fails to remit its payment to the Kennel Dog Robber shall be in default as is provided in Article Two, Section 218 – POUND DEFAULT. (2) A Pack which fails to remit its payment to the Kennel Dog Robber shall be in Default as is provided in Article Three, Section 319 – PACK DEFAULT. A new pound (3) or Pack will have (2) years from the issue date of their new charter, (4) unless their local state or commonwealth requires incorporation upon formation.

#### Rationale:

Here are the rationales for each change:

- (1) Changing National Headquarters, Marine Corps League to Kennel Dog Robber clearly defines who should be receiving the fines to which the Pound or Pack is held accountable in the next sentence.
- (2) The addition of language for a Pack being in default, provides for the ability for a Pack to be found in default for not submitting the fine payment.
- (3) The addition of the words "or Pack" provides the mandate that Packs, as well as Pounds, must incorporate within two years.
- (4) The last addition provides for more immediate incorporation requirements for both Pounds and Packs if their local state or commonwealth should mandate it. There are states that do not allow a nonprofit to operate within their state lines unless they are incorporated, meaning failure to incorporate could result in possible punitive action by the state or commonwealth.

#### Change to read:

- I. Any Pound, the Charter of which has been revoked, shall surrender to the Pack having jurisdictional authority over said Pound, or to the Kennel Executive Director on behalf of the Kennel Board of Trustees as jurisdictional authority, should no Pack having jurisdictional authority exist, all properties and assets to said jurisdictional authority, to be held for a period of one (1) year or until a new Pound is formed. Should a new Pound be formed during that period, the new Pound retains the old Pound name and number. ALL properties and assets will be returned. After the one (1) year, the properties and assets shall revert to the jurisdictional authority, Pack or Kennel. The Charter will be returned to the Kennel Executive Director and placed in the archives. All assets will then become the property of the jurisdictional authority, Pack or Kennel.
- J. The ruling of the lower authority shall be in full force and effect unless, and until, reversed and/or modified by higher authority.

# Section 1202 - Bond

Bond shall be required of all members of the Order who are designated to handle monetary funds at the Kennel, Pack, or Pound level. This will include the Honorable Chief Devil Dog, the Honorable Kennel Dog Robber, all Worthy Pack Leaders and Worth Pack Dog Robbers, and all Pound Keepers and Pound Dog Robbers, as well as any additional Member that the respective Kennel, Pack or Pound shall so designate in their Bylaws.

Change to read:

#### Section 1202 - Bonding

All officers within the Kennel, any Pack or any Pound, within the Order, designated to handle funds are included under a blanket bond provided through a commercial crime policy paid for and administered by the Marine Corps League, National Headquarters, within the territorial provisions of the commercial crime policy. The bond limit will be in the amount of \$10,000.00 with a deductible of \$1,000.00. The Kennel, any Pack or Pound shall arrange any additional bonding coverage desired for their respective Officers. In accordance with the terms of the Marine Corps League's Commercial General Liability Policy, the "Coverage Territory" includes the United States of America (including its territories and possessions), Puerto Rico and Canada. The same holds true for the Bonding Policy. All existing and newly forming off-shore Pounds

will be responsible for securing their own Commercial General Liability Policy and Officer Bonding Policy. The Marine Corps League Inc. must be named as an "Additional Insured" in each policy and must also be "Held Harmless" in the addendum to such policies. A "Summary of Coverage's" and a copy of the policies must be submitted to Marine Corps League National Headquarters annually by all off-shore Pounds indicating that the referenced policies are current.

# Rationale:

The existing language appears to indicate that the Kennel as well as each Pack and Pound are required to obtain their own policies. Changing to this language would indicate that the Kennel as well as each Pack and Pound are already covered. In addition, it provides the current liability limit and the current deductible amount of the current policy as well as information for any offshore Pound, should any be created.

In the event of the dissolution or final liquidation of the Order, the remaining net assets shall be distributed to such nonprofit corporations or associations as are exempt from Federal Income tax under Section 501(c) of the Internal Revenue Code, as the Board of Trustees in the exercise of it discretion may determine, and no part of such net assets may inure to the benefit of any individual member or person.

Change to read:

# Section 1213 - Dissolution

Upon the dissolution of the Order, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(4) of the Internal Revenue Code, or corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Rationale:





The current language does not meet the existing standards as stated by the Internal Revenue Service. This language is a requirement from the Internal Revenue Service to be included in the bylaws of a 501(c)(4) organization. This information has been verified on the sample organizing document – Draft A – located on the Internal Revenue Website <a href="https://www.irs.gov/charities-non-profits/charitable-organizations/life-cycle-of-a-public-charity-sample-organizing-documents-draft-a-charter">https://www.irs.gov/charities-non-profits/charitable-organizations/life-cycle-of-a-public-charity-sample-organizing-documents-draft-a-charter</a>. While this document references a 501(c)(3) tax exempt organization, the same rules apply to a 501(c)(4) tax exempt organization.
