

In light of the considerable amount of noteworthy Marine Corps and MODD history coming out of Belleau Wood I was surprised at how few things I was able to find for the Jr. Vice Chief Devil Dog raffle at Mid-Winter.

For Dogs looking for Belleau Wood items for yourselves during this centennial year, I only found three items so far. First, the U.S. Mint produced a set which includes a WWI Centennial 2018 Silver Dollar and Marine Corps Medal set with the medal featuring Belleau Wood and the report to higher HQ's, "Woods now U.S. Marine Corps Entirely." While the mint quit taking orders in February, the sets should be available at coin dealers and online once dealers receive their orders in late May or April. I believe the Post Office has carried similar coin sets in the past, so you might check there.

The other two items I found were a Belleau Wood patch and solid copper challenge coin which were donated to the Kennel for the Mid-Winter raffle thanks to Jack Hinton and his Marine father Allyn. Allyn is a League member and Vietnam chopper pilot. Both patch and coin feature the Devil Dog Fountain at Belleau Wood and the coin has the WWI Eagle Globe and Anchor on the other side. It is that time of year again when anyone wishing to advance to PDD at the Supreme Growl in Buffalo needs to get their request to me. They must be in my hands prior to **July 1**. If the Advancement papers are not in on time you may be denied the opportunity to go through initiation and be obligated as a PDD. Please remember that the **Pack Dog Robber** must sign the request for advancement and that a copy should be kept by the Pack, Pound and by the individual Dog. Please bring your copy of the request with you as insurance against anything going wrong.

Please remember that the bylaws have changed. You must be in attendance by 5:00 PM on Monday.

Passport funds continue to arrive with many more Pounds contributing. However there are still way too many Pounds and Packs that have not sent in their bones. Pounds and Packs are required by the bylaws to hold at least 4 Growls per year. If you are holding the required Growls then the fee for stamping the passports should be sent in. The children's hospital in New York will be very grateful for your contribution.

I continue to receive Installation Reports with dates other than Sept through Nov. The bylaws state that Pound elections are to be held within that time period. **We are not the same as the League.**

All Packs and Pounds should be incorporated in order to protect themselves and to allow them to legally collect donations. Each should also have a EIN number from the IRS and be filing 990 forms annually. Send the information to the Kennel Dog Robber. If you do not file your taxes the IRS will revoke your tax exempt status. Trust me, you do not want to go through the hassle of all the paperwork and time to get reestablished as a tax exempt organization. There is a new version of the Installation Report on the Kennel web site Please use them.

We will no longer keep or send out hard copy forms. The only ones that will be available will be on the web site. Use those forms.

Many members have still not renewed their membership for 2018. **Dog Robbers: Please follow up on this and get them paid!**

Three major awards are presented at the Supreme Growl, Kennel Dog of the Year, Kennel Pound Dog Robber of the year and Kennel Pack Dog Robber of the year. Nominations have been pitiful! If you have a Dog that you think is worthy of this honor please take the time to make the submission. Follow instructions in the bylaws and get them to me prior to July 20.

For the most part, these requirements are not difficult to meet. There is no excuse for any Pound or Pack to not be able to accomplish the following, and remain in good standing:

- 1. Pound hold four (4) growls a year.
- 2. Pound Election of Officers to happen within ninety (90) days after the Supreme Growl.
- 3. Pound Installation Report submitted to Kennel immediately after election/installation growl. Make sure correct and complete information is in it.
- 4. Pound members working to bring in new members to the Order, and a Mad Dog that will conduct a Pup Initiation that is welcoming/motivating/educational to all new Pups.
- 5. Pound mail in their Passport Bones collected in a timely manner, preferably after each growl.
 - 6. Pack Grand Growl, to be held in conjunction with the Department Convention.
 - 7. Pack Election of officers at the Grand Growl along with the installation ceremony.
- 8. Pack Installation Report submitted to Kennel immediately after Grand Growl. Make sure correct and complete information is in it.
- 9. Pack Initiation Team, and a Mad Dog that does a fun/honorable/memorable initiation for Pups and Devil Dogs.
- $10.\ Pack$ mail in their Passport Bones collected during their growls to the Kennel shortly after the growl.

This information is to clarify any doubt on each Pound and Pack having their own Employer Identification Number (EIN).

Section 702 - Uniform

Existing Wording:

The official uniform of the Military Order of the Devil Dogs, Inc. shall be as follows:

- A. An embroidered official insignia may be worn on the right sleeve of the shirt with the top of the insignia one and one-half (1-1/2) inches below the shoulder seam.
- Shirts worn as part of the uniform shall be white. The Sunburst insignia will be worn on the collar. MCL ribbons
 or USMC ribbons may be worn, but not a mixture of both. Shirts bearing the embroidered official insignia and
 lettering of the Order on the back may also be worn.
- C. The cap patch of the Military Order of the Davil Dogs, Inc., is to be sewn on the right-hand side of the Marine Corps League cap, centered over the piping, (gold piping in the Detachment member cover and the Department Officer cover, red piping on the National Officer cover); so that one-half [1/2] of the patch extends from either side of the piping. The eyes of the Bull Dog on the Patch should be level to the "dock" and the Gold Trench Helmet will be canted to the left side of the Bull Dog's head. The bottom line of the helmet touching the Bull dogs head on either side should be parallel to the piping on the cover. No pins, stars, medals, or any other devices shall be worn on the cover without the official approval of the Kennel. Gold caps may be worn by Kennel Officers, but they must revert to the cap they are authorized after their term of office with the exception of the Chief Devil Dog. Past Chief Devil Dogs are authorized to wear the Gold with Black Crown Cover with red piping. The dates of tenure must be sewn on the cap in red lettering. (See the illustration at the end of the Ritual).
- The individuals name and Pound number may appear above the left pocket of the shirt and officer's title may
 appear above the right breast pocket with the height of the letters not to exceed three quarters of an inch
 (3/4"). Letters must be all one color, gold, rad or block.
- E. A Gold Beret with gold tassel and red lettering shall be optional headgear for all Pedigreed Devil Dogs while in that Degree.
- F. A Red Beret with a red tassel and blue lettering shall be optional headgear for all Devil Dogs while in that Degree.
- G. A Black Beret with a black tassel and white lettering shall be optional headgear for all Pups while in that Degree.
- H. Attached to the Beret shall be a Devil Dog shoulder patch, the affixing of which will indicate the front of the Beret.
- Lettering in colors indicated by "E", "F" and "G" of this section and appearing on the left side of the Beret shall indicate the office held and the dates of tenure and lettering on the right side of the Beret will indicate the Pound name and number.
- Marine Corps Dress Blue with red stripe or black trousers may be worn with the Devil Dog uniform.

Proposed Wording:

The official uniform of the Military Order of the Devil Dogs, Inc. shall be the Marine Corps League Cover with Patch and the M.O.D.D. Identification tag.

A. The cover patch of the Military Order of the Davil Dogs, Inc., is to be sewn on the right-hand side of the

Marine Corps League cover, centered over the piping, (gold piping in the Detechment member cover and the Department Officer cover, and piping on the National Officer cover); so that one-half (1/2) of the patch extends from either side of the piping. The eyes of the Bull Dog on the Patch should be level to the "deck" and the Gold Trench Helmet will be conted to the left side of the Bull Dog's head. The bottom line of the helmet touching the Bull dogs head on either side should be parallel to the piping on the cover. No pins, stars, medals, or any other devices shall be worn on the cover without the official approval of the Kennel. Gold covers may be worn by Kennel Officers, but they must revert to the cover they are authorized after their term of office with the exception of the Chief Devil Dog. Past Chief Devil Dogs and Honorary Chief Devil Dogs are suthorized to wear the Gold with Black Crown Cover with red piping. The dates of tenure must be sewn on the cover in red lettering. (See the illustration at the end of the Ritsul).

Optional Uniforms

- B. Shirts worn as part of the optional uniform shall be white aviator short or long sleeve, with sleeve patches. The Sunburst insignia will be worn on the collar. MCL ribbons or USMC ribbons may be worn, but not a mixture of both. Marine Corps Dress Blue with red stripe or black trousers.
- C. An embroidered official insignia may be worn on the right sleeve of the shirt (in place of the American Flag) with the top of the insignia one and one-half (1-1/2) inches below the shoulder seam.
- D. Shirts bearing the embroidered official insignia and lettering of the Order on the back may also be worn.
- E. The individuals name and Pound number may appear above the left pocket of the shirt and officer's title may appear above the right breast pocket with the height of the letters not to exceed three quarters of an inch (3/4*). Letters must be all one color, gold, red or black.

Optional Headgrean

- F. A Gold Benet with gold tassel and red lettering shall be optional headgear for all Pedigreed Devil Dogs while in that Degree.
- A Red Beret with a red tassel and blue lettering shall be optional headgear for all Devil Dogs while in that Degree.
- H. A Black Beret with a black tassel and white lettering shall be optional headgear for all Pups while in that Degree.
- Attached to the Beret shall be a Devil Dog shoulder patch, the affixing of which will indicate the front of the Beret.
- Lettering in colors indicated by "F", "G" and "H" of this section and appearing on the left side of the Beret shall indicate the office held and the dates of tenure and lettering on the right side of the Beret will indicate the Pound name and number.

Rational:

The Marine Corps League Cover is the only "Official" uniform of the Marine Corps League. The Military Order of the Devil Dogs being a subsidiary organization of the Marine Corps League should not require a more stringent uniform.

- A. ELECTED The elected officers of the Kennel shall be: Honorable Chief Devil Dog, Honorable Senior Vice Chief Devil Dog, Honorable Junior Vice Chief Devil Dog, Honorable Kennel Smart Dog, Honorable Kennel Dog Trainer, Honorable Kennel Police Dog, and Honorable Kennel Mad Dog.
- APPOINTED After the election, the Kennel Board of Trustee's will appoint with approval of the Past Chief's Society a Honorable Executive Director.
- C. APPOINTED After the election, the Honorable Chief Devil Dog-elect will appoint an Honorable Kennel Dog Robber/ Honorable Kennel Watch Dog, and an Honorable Kennel Barking Dog, in such time as will permit their installation into office with the elective officers and these officers will serve at the convenience and pleasure of the Honorable Chief Devil Dog.
 - 1. It is preferable that the Honorable Chief Devil Dog-elect shall appoint to the office of

Honorable Kennel Dog Robber a Pedigreed Devil Dog who is experienced in the duties and responsibilities of the Dog Robber at either the Pound or Pack level.

Rational

As in Section 504 the Kennel Board of Trustee's has a responsibility to ensure the smooth running of the Kennel. The Kennel board depends on its director to achieve the MODD's purposes and objectives within the constraints of its budget on a day-to-day basis. The position requires long term goals, implementation and follow through that cannot be short-sighted. The Kennel Executive Director is also responsible for offering guidance to the sitting Chief and Kennel Board of Trustees.

- E. The Honorable Kennel Smart Dog shall interpret and explain the Constitution and Bylaws of the Kennel and any and all rules and regulations established by the Kennel, the Kennel Staff or the Honorable Chief Devil Dog, when requested by competent authority. Such interpretation and explanation shall not be binding, shall not have the effect of law and shall be considered only as advisory opinion, unless, and until approved by the Kennel in publication on the Kennel website and in the spring edition of the Woof-O-Gram. He/she shall receive all proposed bylaws, amendments no later than 01 March and submit them for publication on the Kennel website and in the spring edition of the Woof-O-Gram. The applicable IRS regulation for this determination is 501 (c) 4. Effective immediately, any Pack or Pound which has not provided the Honorable Kennel Dog Robber, with proof of its incorporation by January 1, 2018, will be billed in the amount of seventy-five (\$75.00) dollars and a like amount annually until such proof of incorporation is on file with the Honorable Kennel Dog Robber. All fines will be forwarded to National Headquarters, Marine Corps League, Inc. A Pound which fails to remit its payment to the Kennel Dog Robber shall be in default as is provided in Article II, Section 218 – POUND DEFAULT. A new Pound will have two (2) years from the issue of their Charter.

CHANGE TO READ-

Section 507 - Incorporation

Incorporation is required in all Packs and Pounds. Proof of Incorporation must be provided to the Honorable Kennel Dog Robber with the Charter Application.

RATIONALE:

ADD NEW SECTION

Section 509 - IRS REPORTS

- (a) IRS Forms 990 and 990Z Each Detachment, Department or other entity, including the National subsidiary organizations and National and National subordinate groups, identified in the below sections of Chapter Eight, which directly or indirectly operates under the Congressional Charter and /or the name of the Marine Corps League must annually file with National Headquarters, via their Department, if such exists, a true and complete copy of the front page of its IRS Form 990 or 990EZ (whichever is required to be filed with the IRS) no later than the due date of filing by IRS rules and regulations, normally by November 15 following the end of the fiscal year of June 30, unless an extension has been requested.
- (b) IRS Form 990-N Those Detachments, Departments or other entities which qualify under the IRS regulations may elect to file an IRS Form 990-N, an e-postcard on-line filing. Since there is no printed copy of this filing, these entities will file a copy of the E-Mail Acceptance Receipt that is returned from the IRS. The submission will be via their Department Paymaster. The Department Paymaster will forward the Acceptance Receipts to National Headquarters, or may consolidate these receipts into a single document showing the name of the organization, the EIN, the Submission ID number,
 - and the date the submission was accepted by the IRS. If a consolidated single report is submitted, the document will be certified by the Department Commandant and the Department Paymaster as true and correct and then submitted to National Headquarters. Where there is no jurisdictional Department, the copy of the Acceptance Receipt will be submitted directly to the National Adjutant/Paymaster.
- (c) The IRS Form 990 reports will be utilized by National Headquarters to update the annual report by our Group Exemption filing requirements to the IRS. Failure to file the appropriate 990 reports to the IRS and updating of our annual filing will subject the subordinate or subsidiary entity to the loss of its exempt non-profit status.
- (d) Pounds must submit a copy of their IRS Acceptance filing to the Kennel via the Pack. Packs will also submit their IRS Acceptance filing to the Kennel.

RATIONALE:

As a subsidiary of the Marine Corps League, Inc. and the Military Order of the Devil Dogs, Inc. must comply with all IRS reporting procedures. This amendment will leave no doubt of what action needs to be taken and should be a part of the Kennel Bulaws.

Candidates for Pup so applying must have at least three full years' membership in the Marine Corps League and meet all the other requirements of paragraph C of this Section. Pups so applying for advancement must have two full years faithful service as a Pup, and meet all the other requirements of Paragraph D of this Section.

PROPOSED: Amend Article I – Membership, Section 101 – Eligibility 5 by removing "wherein refusal would cause undue hardship and gross inconvenience. Candidates for Pup so applying must have at least three full years' membership in the Marine Corps League and meet all the other requirements of paragraph C of this Section. Pups so applying for advancement must have two full years faithful service as a Pup, and meet all the other requirements of Paragraph D of this Section."

RATIONALE: To deny a potential Candidates for Pup and Pups applying to advance the Devil Dog at the Supreme Growl by making them be in the League for three years before they join the Order, and two years respectfully to become Devil Dogs, is denying the Military Order of the Devil Dogs, Inc., new blood that the Order is looking to add as Dogs or advance a further degree.


